

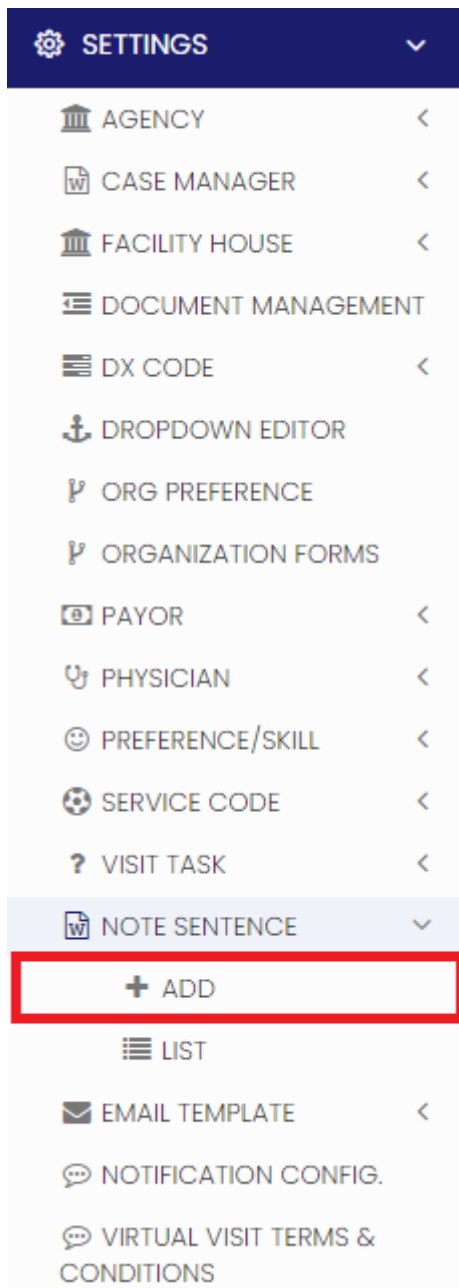
# Note Sentence


